2 Flammability Test

Result: Ignited but self-extinguished before burn rate could be determined

As per Standard Operating Procedure for Determining Lead (Pb) in paint and other similar surface coatings, test method CPSC-CH-E1003-09.1 was used and total Lead content was determined by Inductively Coupled Argon Plasma Spectrometry.

Assessment: Since no scrapable surface coating was found on the submitted samples, the testing scope was not applicable to the submitted samples.

7 Total Lead (Pb) Content

As per U.S. Code of Federal Regulations Title 16 Part 1303, acid digestion method per ASTM E1613-04 / E1645-01 was used and total Lead content was determined by Inductively Coupled Argon Plasma Spectrometry.

Assessment: Since no scrapable surface coating was found on the submitted samples, the testing scope of 16 CFR 1303 was not applicable to the submitted samples.
