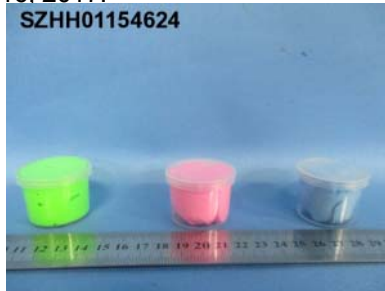

2 Flammability Test

As per section 4.2 of the ASTM Standard Consumer Safety Specification on Toy Safety F963-16, the sample was tested according to Annex A5 Flammability Testing Procedure for Solids and Soft Toys.

Result: Ignited but self-extinguished before burn rate could be determined.

3 Heavy Elements Analysis in Non-Surface Coating Materials (Modelling clay)

As per Section 4.3.5.2(2)(b) and Section 8.3.2 to 8.3.5 of the ASTM Standard Consumer Safety Specification on Toy Safety F963-16, heavy elements migration content were determined by Inductively Coupled Argon Plasma Spectrometry.
