AS PER U.S. CODE OF FEDERAL REGULATIONS TITLE 16 CFR 1303 AND U.S. CONSUMER PRODUCT SAFETY IMPROVEMENT ACT 2008 (H.R. 4040), TITLE I, SECTION 101 FOR CHILDREN'S PRODUCTS CONTAINING LEAD, ACID DIGESTION METHOD WAS USED AND TOTAL LEAD CONTENT WAS DETERMINED BY INDUCTIVELY COUPLED ARGON PLASMA SPECTROMETRY.

RESULT : 64 ppm

REQUIREMENT:

THE TOTAL LEAD CONTENT SHALL NOT EXCEED 600 ppm AS REQUIRED BY 16 CFR 1303. HOWEVER, AS OF AUGUST 14, 2009, THE LIMIT FOR TOTAL LEAD CONTENT WILL BE LOWERED TO 90 ppm IN ACCORDANCE WITH THE CONSUMER PRODUCT SAFETY IMPROVEMENT ACT OF 2008 (CPSIA).

AS OF AUGUST 14, 2011, THE LIMIT FOR TOTAL LEAD CONTENT WILL BE LOWERED TO 100 ppm UNLESS THE CPSC DETERMINES THAT A LIMIT OF 100 ppm IS NOT TECHNOLOGICALLY FEASIBLE FOR A PRODUCT OR PRODUCT CATEGORY.
